ASA CIRCULAR 46 OF 2020 ASA REGISTRATION FORM FOR 2021 ATHLETICS SEASON

Dear ASA Members

Please find attached the template, to be used during the issuing of 2021 ASA Licenses. Please note that ASA need to adhere to the requirements of the Department of Sport, Arts and Culture, with regards to the development and transformation that takes place in particular on club and school level.

It is therefore important that the section in red on the attached application form, are completed before a license is issued to the club. It is the responsibility of the club to verify that the section highlighted in red in the registration form, is completed correctly.

Provinces must give guidance to clubs as to how Primary School and High School Athletes, whom want to participate in the district and provincial championships, must register as an ASA Licensed Athlete.

Lastly, but most importantly, in accordance with World Athletics (WA) and National Athletics (ASA) Rules and Regulations, athletes must be declared eligible before the athlete can participate in any international event, irrespective the level of competition.

In South Africa, the above implies that the athlete must be in possession of an ASA Permanent License, before the athlete can represent South Africa internationally, at any level of competition.

In summary, ASA Permanent Licensed athletes can qualify for a South African team, to represent South Africa internationally, at any club, provincial, national or international competition listed on the ASA National/Provincial fixtures lists, subject to the ASA Selection Criteria.

Likewise, school athletes can qualify for age category international teams at district, provincial and national competitions, listed on ASA National/Provincial fixtures lists, and subject to ASA Selection Criteria.
